- 3. Space Assignment. Each exhibit area will include one 6-foot table with linen, wastebasket, electrical outlet, chair, and complimentary wireless internet access. Exhibition space will be assigned by the Seminar committee, based upon exhibitor preference and by the date of receipt of contract and payment.
