- The Board of Directors meeting will be September 11, 1971 at Holiday, Inn, Ontario, Ca.
- Southern Regional Meetings are set for August 20, 1971, place to be announced, Los Angeles, and September 17, 1971 Athaneum, Cal. Tech. Check with Dick Shaw, Member-at-Large (South) for additional information.
- 9. The City of Huntington Beach, California, Police Department is accepting applications for Police Criminalist. Huntington Beach is one of the fastest growing cities in the United States. The city grew from 10,000 population/10 square miles in 1960 to 124,300 population/26.7 square miles in 1970. The projected 1985 population is in excess of 300,000.

In addition, the City expects to annex up to seven square miles of unincorporated areas. The City currently has three 18 hole golf courses, large industrial parks, more than nine continuous miles of beaches, a private airport and a Community College. Two State Colleges and a University are within easy commuting range. The Police Department is expanding with the City. Construction of a new Civic Center including an 84,000 square foot Police Facility will start in January of 1972. The facility will contain a 2,700 square foot Scientific Investigation Bureau. The criminalist will participate in the finish design and equipping of the laboratory.

The Job: A Criminalist searches for, collects and preserves physical evidence in the investigation of crime and suspected criminals; examines evidence by means of physical and chemical analysis; and gives expert testimony in court.

<u>Duties</u>: The Criminalist will perform minimal photography and field work. Approximately 90% of the field work is done by Crime Scene Investigators and the Photo-Dark Room is staffed by a photo-technician. The Criminalist will make chemical or physical analysis and microscopic examinations in the identification and comparison of evidence. Must have the ability to qualify in the Superior Courts of California as a Criminalist and provide expert testimony in the field of Criminology.

Requirements: 21 to 35 years of age (Extended to maximum of age 40 with two years of Criminalist experience for each year over 35). Graduation from a recognized four year college or university with a major in chemistry, physics or criminalistics and five years experience in an accredited crime laboratory.

Salary: \$13,656 to \$17,028 yearly.

Benefits: Paid overtime or time off, state retirement system, health insurance paid by City, holiday overtime pay, disability insurance, vacation and sick leave.
