A. Spring 1975

Hosted by The Aerospace Corporation, with Dr. Peter Jones handling the responsibilities, this seminar will be held in Los Angeles on May 15, 16, and 17. It will be held at the Sheraton Airport Hotel. A workshop is planned for one segment of the program and it is anticipated that the banquet speaker will have a national perspective on the Criminal Justice System. Be prepared to submit your outline and abstract when the "call for papers" is received.

B. Fall 1975

The <u>California Department of Justice Regional Laboratory</u>, Fresno is hosting this seminar with David Sanchez coordinating the efforts of the members of the laboratory. The most unusual aspect of this meeting, at least for the present, is that it will be held on Friday, Saturday, and Sunday rather than the usual Thursday, Friday, and Saturday. The dates are October 10, 11, and 12, 1975.

B. YOUR PUBLICATION - THE JOURNAL OF THE FORENSIC SOCIETY

CAC has a space allocation in the Journal of the Forensic Science Society which is also the official organ of the Society by the same name. All our papers are reviewed and accepted by us in the CAC for publication in the Journal. The Journal only asks that our manuscripts conform to its format and that it has not been published or is not being considered for publication elsewhere.

Prior to preparing your manuscript for the Journal, please study its format carefully. This care will reduce considerably the time required for editorial work and for eventual publication. Delays in publication are often caused by manuscripts being shuttled back and forth between editors and authors. Do not hesitate to write or call your Editorial Secretary for a copy of "Instructions to Authors". Submit your paper in triplicate to the CAC Editorial Secretary.

Our policy is to speed the review work and submit the paper to the Journal for publication. The paper is read by two or more reviewers. Reviewers are generally CAC members, unless it is necessary to find expertise outside the organization.

The reviewers are requested to read the manuscript in ten days and make comments and recommendations. The author(s) are then notified immediately of the disposition of the paper. Papers accepted for publication are air-mailed to London by the CAC.

II. EDUCATION AND TRAINING PROGRAMS OF INTEREST

A. A two-day intensive course, "Forensic Geology and Soils," will be given December 16-17, 1974, at the University of California at Berkeley, sponsored by U.C. Extension in cooperation with the U.C. School of Criminology.

J.C.F. Tedrow, professor of soils at Rutgers University, will be the course instructor. He has served as a consultant to the New Jersey courts for 20 years on forensic soils, especially in criminal cases, and is the author of many articles and a forthcoming book on forensic geology.

The course is designed to bring the basic language of geology and soil science, and the information and technology applicable to problems in criminology, to criminalists, forensic chemists and geologists, law enforcement officers and attorneys. The topic headings include earth materials as physical evidence, properties and distribution of earth materials, the nature of soils and soil materials, the problems of sampling, comparison methods for minerals and soils, the application of geologic information and instruments, and continued research needs.

The registration fee is \$100 and optional academic credit in criminology may be earned.
