DRUG STUDY GROUP

A Drug Study Group meeting was held at the San Mateo County Sheriff's Criminalistics Laboratory on September 1, 1988.

Nick Stumbaugh reported on CCI's course "Clandestine Laboratory Forensic Investigation." Students were taught how to safely examine and process clan lab scenes. Topics included:

- types of labs
- legal aspects
- synthesis routes
- selection, use and hands-on instruction with safety equipment
- DOJ's clan lab safety protocol which must be adhered to in order to work with DOJ and / or DEA at clan lab scenes
- coordination of law enforcement
- a binder of reference materials

The course seems to be well worth taking. John Bowden added that the course will be offered again early next year if enough applications are received.

A list of chemicals for which cartridge type air purifying respirators should not be used was passed around.

The San Mateo County Sheriff's office has prepared two training manuals: "Clandestine Drug Laboratory Manual" and "An Introduction to Clandestine Drug Laboratories". They are available to agencies with a need to know. Contact Nick Stumbaugh at (415) 573-2906.

AB 2700 was signed and chaptered on August 29, 1988. It is effective immediately as emergency legislation. It makes N,N- dimethylamphetamine, analogs and combinations of precursors illegal.

RJM, a large chemical supply house has been seized.

Chemicals for Research and Industry, a chemical supply house in Oakland has purchased inventory from ARC Chemicals at auction.

The Appellate Court decision in John Michael Hall, which concluded that it was "appropriate for one DOJ analyst to testify to the works and conclusions of another, who is unavailable" has been ordered published.

Elliot Kollman and Carolyn Csongradi of SMCSO, have developed a method of extracting LSD for IR analysis. (See accompanying article)

The Drug Study Group-South has proposed the formation of a committee within CAC that would assist legislators in drafting and/or correcting drug legislation. They have at least five people interested in being committee members. Participants are being sought from the North.

SMCSO is tentatively planning to demonstrate the Ephedrine - red P-HI synthesis of Methamphetamine early next year.

EXTRACTION OF LYSERGIC ACID DIETHYLAMIDE

San Mateo County Sheriff's Office

REAGENTS:

1:1 methanol:water 10 M ammonium hydroxide n-butyl chloride 10% hydrochloric acid methylene chloride

PROCEDURE:

1. Cut up one stamp, (or more if you have sufficient sample), and place in a test tube.

2. Add aproximately 1 ml of the 1:1 methanol:water solution, 2 drops of 10M ammonium hydroxide, and approximately 1ml of n- butyl chloride.

3. Place in ultrasonic bath for 5 minutes. Mix. Centrifuge.

4. Remove organic layer and add to it approximately 1ml 10% HCI. Mix. Centrifuge.

5. Remove aqueous layer and basify to PH 9. Add approximately 1 ml methylene chloride. Mix. Centrifuge.

6. Remove organic layer and evaporate in a mortar being careful not to overheat sample.

7. Make a KBr micropellet and analyze.
